Wastewater Business Continues to Expand

In the spring of 2006, the Carver Septage Facility was closed by the Department of Environmental Protection for continued effluent violations. The plant was run down, odors were extremely noxious and most of the equipment was in very poor condition.

In the fall of 2006, Wind River Environmental, a septage hauling company was investigating a lease of the Carver facility as a means of treating the waste they handled. Their biggest issue was trying to get qualified operators to not only operate the facility, but to get all of the equipment back in reliable working order. They were not an operations company and needed someone with experience and a good reputation with the DEP to help them get the plant started.

In October, WhiteWater learned of their predicament and was able to set a meeting with the Chief Executive Officer of Wind River. It didn't take very long to convince Wind River that WWI was the right company for the job. In late November 2006, WWI was hired to provide a Chief Operator/Project Manager for the facility.

After two hectic months repairing equipment, setting up preventative maintenance programs, cleaning and seeding the facility, the DEP gave approval to receive 25,000 GPD of septage. This equated to 25% of the design flow of 100,000 GPD.

In February 2007 the DEP granted approval to increase the daily septage received to 50,000 GPD, and in March granted 75,000 GPD. At each step additional sampling was required to satisfy the DEP that the plant was functioning as designed. In addition, new staff from Wind River had to be brought on board and trained at the same time the plant was ramping up capacity.

Finally, in April, 2007, the DEP approved the facility for 100,000 GPD. The plant is now staffed two shifts per day, seven days per week to meet demand.

Congratulations are in order for all WWI personnel who have worked hard to make this project work. From the opening sales call to operating the plant during weekend and evening hours, WWI personnel have played an integral part in assisting Wind River reach this milestone.

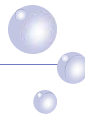
